### **SUMMARY**

The Pharmacist works to the full scope of practice in accordance with the Ontario College of Pharmacists.

# **ACCOUNTABILITY**

The Pharmacist collaborates with all team members and reports to the management team. The Pharmacist must comply with the standards of practice guidelines of the Ontario College of Pharmacists.

### **ROLES AND RESPONSIBILITIES**

## **Medication Optimization**

- The Pharmacist will apply knowledge to identify, prevent, and/or resolve medication-related problems in individual clients. This may include a comprehensive assessment of a client's medication regime synthesizing information from multiple sources to identify, prevent, and/or resolve medication-related problems. Recommendations are made to the nurse practitioner or to the client when appropriate.
- Documents care provided in keeping with policies and procedures of the SFNPLC
- Provides drug information to the team to address questions related to individual clients or generally to support best practices within the Clinic

# Team and Clinic Responsibilities

- Promotes and participates in an interdisciplinary provider model. Collaborates with both providers and clients to ensure that appropriate medication management is provided.
- Participates in the development and evaluation of policies, protocols, and procedures to improve client care and/or promote co-operative and efficient staff functioning.
- Contributes to the development of program plans and develops, plans, implements, coordinates, and evaluates assigned projects in consultation with other team members.
- Participates in the education of students

- Ensures that required statistics are recorded and participates in their analysis
- Contributes where necessary to evaluation processes
- Performs other duties as assigned
